Terms of Conditions for Membership

- 1) 2 (Two) copies of recent colour passport size photograph of the Applicant and Authorized Representative to be attached with membership application form.
- 2) Attach herewith BACI money receipt of application form.
- 3) Certificate of successfully completed projects, each under single construction contract in the last three years. It may be mentioned that a project valuing not less than taka 100 (Hundred) million shall be eligible for enrolment/entrance/admission as member.
- 4) A Company/Firm must have at least 1 (One) Graduate Engineer who is Owner/Director of the Company.
- Account Payee Cheque/Pay Order of Tk 1,00,000/- (One lac) only is to be deposited against "Bangladesh Association of Construction Industry" (BACI) as Membership Application fee.
- a) After obtaining Membership, Annual Subscription fee of Tk 25,000/- (Twenty five thousand) only must be deposited by A/C payee Cheque/Pay Order to "Bangladesh Association of Construction Industry" (BACI). So, a new member has to pay Membership Application fee and Annual Subscription fee for first year only.
 - b) From second year, only Annual Subscription fee of Tk 25,000/- (Twenty five thousand) only shall be paid to BACI account within 31st March of the current year, failing which the following fines shall be paid by the defaulters:
 - b.1) Tk 5,000/- (Five thousand) only in case paid within 30th April.
 - b.2) Tk 7,500/- (Seven thousand five hundred) only in case paid after 30th April but before 31st May.
 - b.3) Tk 10,000/- (Ten thousand) only in case paid after 31st May but before 30th June.
 - c) In case of failure to pay the Annual Subscription fee along with the above stipulated time after expiry of 30th June, the membership shall be deemed to have been ceased and the concern company will have to apply for new membership paying fees as of new member if it intends to continue as a member of BACI. The Board of Directors shall then once again determine its suitability for membership.
- 7) All other rules time to time promulgated by BACI must be observed.
